INSTALLATION TIPS

- ◆ Choose a mounting location suitable to support the full weight of the system when operating.
- ◆ Never use a saddle valve for connection.
- ◆ Use 3/4" water line.
- ◆ Do not connect system to water-cooled condenser.
- ◆ Install vertically with cartridges hanging down. Allow 2 1/2" (6.35 cm) clearance below the cartridge for easy cartridge replacement.
- ◆ Flush cartridges by running water through system for five (5) minutes at full flow.

OPERATION TIPS

- ◆ Change cartridges on a regular six (6) month preventative maintenance program.
- ◆ Change cartridges when capacity is reached or when pressure falls below 10 psi (0.7 bar).
- ◆ Service flow rate must not exceed 5 gpm (18.9 Lpm).
- ◆ Always flush the filter cartridge at time of installation and cartridge change.

- ◆ Service Flow Rate: Maximum 5 gpm (18.9 Lpm)
- ◆ Capacity: 36,000 gallons (136,247 L)


